Dear Moira,

Thank you for writing to me on the subject of the future of the Fine Arts course at UHI Moray.

The Scottish Government recognises culture's unique contribution to society, and the valuable role of creative practitioners and cultural organisations. As set out in" A Culture Strategy for Scotland", we aim to place culture as a central consideration across all policy areas, including education.

The Scottish Government is committed to supporting colleges in their delivery of an offering to learners that is rooted in a robust understanding of local needs, as well as regional and national priorities. However colleges are responsible for their own operational decisions, including course provision, as they are best placed to respond flexibly to emerging trends at local and regional level.

We have been working with the Scottish Funding Council to understand the situation at UHI Moray and we understand that the position is that this is still at the proposal stage for consultation, including with the students, and that, as yet, no decision has been made.

We expect students to be appropriately supported by their institutions and to receive timely information about the options available to them.

Regarding the Moray Growth Deal, Regional Growth Deals are designed to align long term funding behind shared visions for regional economies, leverage additional investment, create new jobs and accelerate inclusive economic growth in each of the areas covered by the 12 Deals. All Deal funding is committed to named projects and programmes, as agreed with regional partners, and Deals are or
